### VII. <u>COMMITTEE REPORTS</u>

#### **Government Affairs Committee**

Eric Holt motioned to appoint Ashley Dietz to the GAC. Joaquin Arrillaga seconded the motion. Vote was taken and the motion carried 6-0

Eric Holt motioned that the WCA Board reaffirm the Boards position in favor of a cell tower at the Glencliff Park. Joaquin Arrillaga seconded the motion. Vote was taken and the motion carried 6-0

### Modifications Committee

Dale Sells motioned to re-appoint JoAnn Gratt, Cynthia Hutton and Steven Splaine to the Modifications Committee with term expiring June 2024; and to move Bradley Lloyd from alternate member to full-time member. Jim Brinker seconded the motion. Vote was taken and the motion carried 6-0

### **Nominating Committee**

Dale Sells motioned to appoint Eric Holt to the Nominating Committee as chair, with Rick Goldstein, Mary Griffin and Blakley Echeverry as members of the committee. Jim Brinker seconded the motion. Vote was taken and the motion carried 6-0

#### Master Plan Committee

The committee presented a list of recommended items for the board to consider for current and future consideration:

<u>Water Slide</u> – rather than replace the slide, the committee is proposing amending the existing stairs or replace for safety reasons; quotes to amend the steps will be requested by some welding companies.

Ice Machines -

Blakley Echeverry motioned to have Avery Construction preplumb a line at the Countryway pool for an outside self dispensing ice machine and to purchase one machine for the CW pool area. Jim Brinker seconded the motion. Vote was taken and the motion carried 5-1 (Eric)

Eric Holt motioned to run plumbing for an ice machine at the West Park village Pool while Avery is also plumbing the CW pool area for an ice machine. Joaquin Arrillaga seconded the motion. Vote was taken and the motion carried 6-0

Banners at Tennis Courts -

Joaquin Arrillaga motioned to have the association manager prepare and present policies to allow banners at the Countryway Tennis facility. Jmi Brinker seconded the motion. Vote was taken and the motion carried 6-0

Bathroom Renovations-

Joaquin Arrillaga motioned to accept the quote from Avery Construction to renovate the bathrooms at Countryway and West Park Village at a proposed cost of \$141,221 and to add an additional \$15,000 for additional proposed changes not included on the quote, with a deposit to be paid for purchasing of supplies, with a September 2022 start date beginning at Countryway. Dale Sells seconded the motion. Vote was taken and the motion carried 5-0-1 (Shawn abstained due to conflict)
