#### I. CALL TO ORDER

#### IV. CONSENT AGENDA

Michele DelSordo motioned to approve the consent agenda item: Feb 9, 2023 meeting minutes. Dale Sells seconded the motion. Vote was taken and the motion carried 7-0

Dale Sells motioned to accept the insurance renewal proposal as submitted by BKS Ins for renewal period 3/20/2023-3/20/2024 for all policies excluding the property ins that renewed 2/23/23. Jim Brinker seconded the motion. Vote was taken and the motion carried 7-0

#### V. OLD BUSINESS

Cyber Security Policy

Eric Holt motioned to approve the proposal prepared by Cowbell Insurance for a Cyber Security policy at a cost of \$1,522.36 with liability limit of \$1,000,000 and a deductible of \$2,500. Michele DelSordo seconded the motion. Vote was taken and the motion carried 7-0

Dale Sells motioned that the Association Manager continues to review our prepaid accounts and make refunds as deemed appropriate. Jack Maurer seconded the motion. Vote was taken and the motion carried 7-0

#### **Government Affairs Committee – report submitted by Eric Holt**

Eric Holt motioned that the GAC be authorized to spend no more than \$300 for the purpose of organizing and conducting a "2023 GAC Reception" at a local private restaurant establishment. Funds are to be used for the purchase of appetizers and non-alcoholic drinks for attendees Blakely Echeverry seconded the motion. Vote was taken and the motion carried 7-0

Jim Brinker motioned for the board to discontinue all discussion relating to bulk fiber optic negotiations. Blakely Echeverry seconded the motion. Vote was taken and the motion carried 7-0

- 5. Neighborhood Specific News GPI (or as requested by Voting Members) Blakely Echeverry seconded the motion. Vote was taken and the motion carried 7-0

## **Exploratory Committee – update provided by Eric Holt**

The Exploratory Committee respectful requested a special meeting of the Board be scheduled for the express purpose of allowing the Committee to formally present their final report; the Committee also requests that GPI personnel not attend this meeting given their notable inclusion in the report and that by doing so would constitute the best climate and practice for ensuring the information is delivered in proper context and also allow time for robust discussion. Said meeting has been scheduled for April 3, 2023 at 6pm and to be located at the S&T Activity Room to allow sufficient room for anticipated attendees.

#### VIII. NEW BUSINESS

Dale Sells motioned to impose a \$1,000 fine on R-1 due to a repeat of the violation during the 3 month suspension period, and for the resident's use of the WCA facilities to be suspended for a maximum of 90 days, with the first day of suspension being the fifth day after confirmation by the Covenant Committee. Michele DelSordo seconded the motion. Vote was taken and the motion carried 7-0

#### • Tabled & Proposed Fines

Dale Sells motioned to not impose a fine on T-2, P-5, 7, 9, 10, 13, 16, 18, and 20-27. Michele DelSordo seconded the motion. Vote was taken and the motion carried 7-0

Dale Sells motioned to accept the proposed motion to table the proposed fine on T-3, P-15 and P-19 to the Apr 2023 board meeting. Michele DelSordo seconded the motion. Vote was taken and the motion carried 7-0

Dale Sells motioned to accept the proposed motion to table the proposed fine on T-4, P-2, 6 and P-14 to the May 2023 board meeting. Michele DelSordo seconded the motion. Vote was taken and the motion carried 7-0

Dale Sells motioned to impose a \$1,000 fine on T-1, P-3, 4, 8, 11, 12 and P-17 and for the resident's use of the WCA facilities to be suspended for a maximum of 90 days, with the first day of suspension being the fifth day after confirmation by the Covenant Committee. Eric Holt seconded the motion. Vote was taken and the motion carried 7-0

Dale Sells motioned to accept the proposed motion to impose a \$1,000 fine on P-1 for the resident's use of the WCA facilities to be suspended, with enforcement suspended and the fines subsequently waived provided the violation does not reoccur within the next 3 months (thru 06/08/2023). Michele DelSordo seconded the motion. Vote was taken and the motion carried 7-0
