Michele DelSordo motioned to approve the consent agenda items July 13 and 27, 2023 meeting minutes. Jim Brinker seconded the motion. Vote was taken and the motion carried 6-0

#### 2024 Draft Budgets #1 - #4

Four different budgets were presented to the board for consideration: Draft#1 resulted from the VM meeting; Draft #2 changed the capital contribution fee to \$500; Draft #3 changed the capital contribution fee to \$750; Draft #4 changed the capital contribution fee to \$1,000

Dale Sells motioned for the reserves for the WCA Mgmt Office Building Main Server (line 197) and Printer (line 201) be released (\$8,415) and reallocated to Village Swim & Tennis Club Pool Resurfacing (line 147). Jim Brinker seconded the motion. Vote was taken and the motion carried 6-0

Dale Sells motioned to approve Draft Budget #3 changing the number of closings per month to 11, setting the capital contribution fee to \$750 and to match the USTA fee in the income section to the same amount as the insurance cost – final assessment calculated to be \$364. Michele DelSordo seconded the motion. Vote was taken and the motion carried 5-0-1 (Eric)

Dale Sells motioned to table the proposed fine on P-19, 20, 22 and P-26 to the Sept 2023 board meeting. Jim Brinker seconded the motion. Vote was taken and the motion carried 6-0

Dale Sells motioned to table the proposed fine on P-5 and P-13 to the Oct 2023 board meeting. Michele DelSordo seconded the motion. Vote was taken and the motion carried 6-0

Dale Sells motioned to impose a \$1,000 fine on T-1, P-6, 7, 15, 17, 18 and P-23 and for the resident's use of the WCA facilities to be suspended for a maximum of 90 days, with the first day of suspension being the fifth day after confirmation by the Covenant Committee. Jim Brinker seconded the motion. Vote was taken and the motion carried 6-0

Dale Sells motioned to accept the proposed motion to impose a \$1,000 fine on P-1, 2, 9, 10, 11 and P-12 for the resident's use of the WCA facilities to be suspended, with enforcement suspended and the fines subsequently waived provided the violation does not reoccur within the next 3 months (thru 10/12/2023). Michele DelSordo seconded the motion. Vote was taken and the motion carried 6-0
