## IV. Minutes

#### Approval of Meeting Minutes for Nov 14, 2023 Minutes

Rick Goldstein made the motion to approve the 11/14/23 meeting minutes. Russ Crooks seconded the motion. A vote was taken and the motion passed 26-0

## V. New Business

## Amendments to Residential Guidelines and Baybridge INSG

- (1) <u>Section 2.2.13 of the Guidelines</u>: The draft amendment would allow aluminum fences that comply with section 2.2.15.C to extend to the rear Lot line on any Lot that abuts a lake, pond or conservation area (despite "no fence zone" language in any INSG). Several INSGs currently provide that fences on lots that abut ponds and conservation areas may not extend more than half way back toward the rear properly line. The amendment would allow aluminum fences to extend to the rear property line because they do not obstruct views.
- (2) <u>Section 2.1.12 of the Guidelines</u>: Several owners have requested black garage doors. The draft amendment would add 6258 Tricorn Black to Appendix A-6 as an approved color for trim. Consequently, if the amendment is approved, Tricorn Black would be authorized for garage doors, exterior entry doors, borders around windows, and all other elements of "trim" as defined in section 2.1.12 of the Guidelines.

(3) <u>Baybridge INSGs</u>: The draft amendment would revise requirements for fences on lakes, ponds or conservation areas, by removing the no fence zone, removing different options for fence heights and clarifying that that only metal fences which comply with section 2.2.15.C of the Guidelines may be installed in yards that abut lakes, ponds, or conservation areas. (Because section 2.2.13 of the Guidelines was amended to provide that only metal fences are permitted on Lots that abut lakes, ponds, or conservation areas, there is no longer a need for a no fence zone to protect views against vinyl or wood fences in Baybridge.)
