Rick Goldstein motioned to approve the Feb 7 & Feb 8, 2024 meeting minutes. Terry Boyd seconded the motion. Vote was taken and the motion carried 6-0

O-1 10309 Lightner (Sanchez)

Rick Goldstein motioned on O-1 to give the owner 60 days to fix the violation, and if in compliance by the deadline, then the fine is waived. Terry Boyd seconded the motion. Vote was taken and the motion carried 6-0.

O-2 10420 Snowden (Daniels)

Jim Brinker motioned waive the entire fine on O-2. Rick Goldstein seconded the motion. Vote was taken and the motion carried 6-0

O-3 10114 Radcliffe (Petit)

Jim Brinker motioned to waive the entire fine on O-3. Rick Goldstein seconded the motion. Vote was taken and the motion carried 6-0.

O-4 9706 WPV (Cantu)

Jim Brinker motioned on O-4 to give the owner 120 days to fix the violation, and if in compliance by the deadline, then the entire fine is waived. Rick Goldstein seconded the motion. Vote was taken and the motion carried 6-0.

• <u>Tabled & Proposed Fines</u>

Jim Brinker motioned to not impose a fine on T-1, P-4, 8, 9, 12, 20, 25, 33, 40, 43 and P-45. Terry Boyd seconded the motion. Vote was taken and the motion carried 6-0

Jim Brinker motioned to table the proposed fine on P-26, P-27 and T-2 to the Apr 2024 board meeting. Terry Boyd seconded the motion. Vote was taken and the motion carried 6-0

Jim Brinker motioned to table the proposed fine on P-14 to the May 2024 board meeting. Terry Boyd seconded the motion. Vote was taken and the motion carried 6-0

Jim Brinker motioned to impose a \$1,000 fine on P-21 and P-29 and for the resident's use of the WCA facilities to be suspended for a maximum of 90 days, with the first day of suspension being the fifth day after confirmation by the Covenant Committee. Terry Boyd seconded the motion. Vote was taken and the motion carried 6-0

Jim Brinker motioned to impose a \$1,000 fine on P-2, 13, 15, 16, 22, 23, 31, 34, 37, 41 and P-44 and for the resident's use of the WCA facilities to be suspended, with enforcement suspended and the fines subsequently waived provided the violation does not reoccur within the next 3 months (thru 06/13/24). Michele DelSordo seconded the motion. Vote was taken and the motion carried 7-0

Jim Brinker motioned to impose a \$1,000 fine on P-1, 3, 5, 6, 7, 10, 11, 17, 18, 19, 24, 28, 30, 32, 35, 36, 38, 39 and P-42 and for the resident's use of the WCA facilities to be suspended, with enforcement suspended and the fines postponed until 05/14/24, and in the event the non-compliance is cured by 5/14/24 the fine shall be waived and use suspension terminated. Michele DelSordo seconded the motion. Vote was taken and the motion carried 7-0

Summer Camp Field Trip Options

Two new options for summer camp field trips were proposed by the Facility Manager for the 2024 camp season: Lithia Springs Park and Cypress Point Park. After much conversation between the Board and the Facility Manager, the board voted as follows:

Rick Goldstein motioned to deny the request by the Facility Manager to take the summer camp children to Cypress Point Park & Lithia Springs for field trips. Michele DelSordo seconded the motion. Vote was taken and the motion carried 5-1 (Shawn)

> Summer Camp - PDQ Opportunity

Josh Fernandez from PDQ Westchase approached the Board about potentially partnering with us for the summer camp program to offer discounted box lunches for the kids and staff. Since the association doesn't provide meals for participants, PDQ offered discounted meal packages for the parents with delivery to the campers by PDQ. It was recommended by the Board for the Facility Manager to be in communications with Mr Fernandez and the logistics of box lunches for participants.

Video Recording Board Meetings

At the March 12th Voting Members meeting, it was voted 8-14 to NOT request the Board consider video recording and storing the recordings as official records. Eric Holt, Radcliffe VM, informed the Board in writing that he was going to video record all meetings of the association beginning with the Mar 14th Board meeting.

After discussion, the Board took no action for recording Board meetings.
