# • <u>Reaffirmed, Tabled & Proposed Fines</u>

Jack Maurer motioned to table P-18, 20, 23, 38, 49, 52, 58 and P-59 to the April board meeting. Terry Boyd seconded the motion. Vote was taken and the motion carried 5-0

Jack Maurer motioned to impose a \$1,000 fine on P-3-7, 10, 12, 14, 15, 16, 24, 25, 27, 31, 34, 35, 43, 47, 54, 55, 56, 60 and P-61 and for the resident's use of the WCA facilities to be suspended for a maximum of 90 days, with the first day of suspension being the fifth day after confirmation by the Covenant Committee. Terry Boyd seconded the motion. Vote was taken and the motion carried 5-0

Jack Maurer motioned to impose a \$1,000 fine on P-45, but waive if photographic proof showing side of house cleaned and painted is provided no later than 4/10/25. Terry Boyd seconded the motion. Vote was taken and the motion carried 5-0

Jack Maurer motioned to impose a \$1,000 fine on P-33, but waive if corrected by 5/2/25. Terry Boyd seconded the motion. Vote was taken and the motion carried 5-0

Jack Maurer motioned to not impose a fine on T-1, T-2, P-1, 2, 8, 9, 11, 13, 17, 19, 21, 22, 26, 28-30, 32, 36, 37, 39-42, 44, 46, 48, 50, 51, 53, 57, 62-65. Terry Boyd seconded the motion. Vote was taken and the motion carried 5-0

#### > Request From VMs to Increase Allowance for Audio/Visual Equipment by \$1500

Jack Maurer motioned to increase the allowance for audio visual equipment by an additional \$1,500 over current approved budget. Terry Boyd seconded the motion. Vote was taken and the motion carried 5-0

#### > Insurance Policies Eff. 3/20/25 Proposals (Brown & Brown)

Rick Goldstein motioned to approve the insurance proposals as submitted which included the Harco option for Crime & D&O being combined, and opting to go with the Coalition option for Cyber, resulting in a total insurance renewal of \$84,136.08 for all policies excluding the property. Terry Boyd seconded the motion. Vote was taken and the motion carried 5-0

#### Bathroom Renovation Quote – Revised

Jack Maurer motioned to accept the revised quote from Hoffman Designs for the bathroom renovations, at a revised cost of \$83,486.40. Rick Goldstein seconded the motion. Vote was taken and the motion carried 5-0

Jack Maurer motioned to approve the new style of tile options as presented for the bathrooms and rescind the original selections previously approved. Rick Goldstein seconded the motion. Vote was taken and the motion carried 5-0

#### > Pool Deck Hole Repair Quote (GA Nichols)

Michiel Oostenbrink to continue to work with engineers and GA Nichols on proposed quote to repair hole found in deck near pool slide.

#### Trash Removal Services – Republic vs. Waster Mgmt Proposals

Nancy Sells motioned to approve the proposal from Waste Mgmt for trash removal service and to stipulate that a limit of 6% annual increase be incorporated into a three year contract. Terry Boyd seconded the motion. Vote was taken and the motion carried 5-0

#### Destruction of Association Records List

Nancy Sells motioned to approve the list of items earmarked by management of association records in storage to be destroyed per the Associations Records of Destruction Policy. Jack Maurer seconded the motion. Vote was taken and the motion carried 5-0
